COOKIE POLICY

- 1. Personal data processor, Galerie Zdeněk Sklenář s.r.o., with registered office at Mikulandská 135/7, 110 00 Prague 1 New Town, Czech Republic as a company operating this website, is using cookies and system data on this website that are used for the following purposes:

Such processing is enabled by a lawful title legitimate interest of the processor pursuant to clause 6 para 1 letter f) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter referred to as "Regulation").

If you look onto our webpages and you have permitted in your browser storing of cookies, you agree that Galerie Zdeněk Sklenář will via cookies process records of your behavior on the said webpages for the purpose of enhancing users' comfort during repeated visits and for tuning their functionalities and adjustment to your preferences and for the purpose of obtaining web advertising services from providers of such systems and services. Webpages may be used also in mode that does not allow data collection regarding behavior of their visitors such mode may be set in your browser settings or you may raise a complaint against use of legitimate lawful reason on the side of the processor pursuant to clause 21 of the Regulation.
